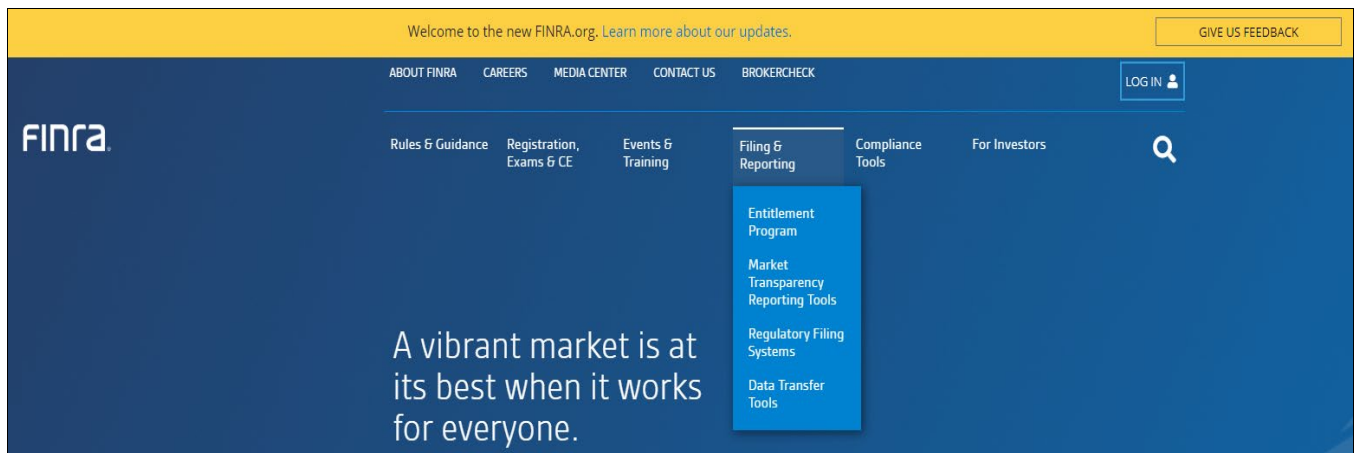
Overview of the Advertising Regulation Electronic Files (AREF) System

- AREF, accessed through FINRA Gateway Compliance Portal Dashboard. Within the FINRA Dashboard Links section, select the Advertising-Ad Reg link, which allows FINRA-regulated firms to submit information to be reviewed by the FINRA Advertising Regulation Department and to receive FINRA review letters.
- In AREF users can:
 - submit filings/New Communications with the public;
 - view and save communications sent by FINRA’s Advertising Regulation Department to their firm; and
 - search AREF to view and save archived letters.
- AREF users must obtain a user ID and password from their firm’s Super Account Administrator (SAA).

Getting Started – “Entitlement”

Super Account Administrator – may grant access to the AREF system to anyone at your firm. For more information on FINRA’s SAA Entitlement Program go to FINRA.org:

- Hover “**Filing & Reporting**”
- Click “**Entitlement Program**”

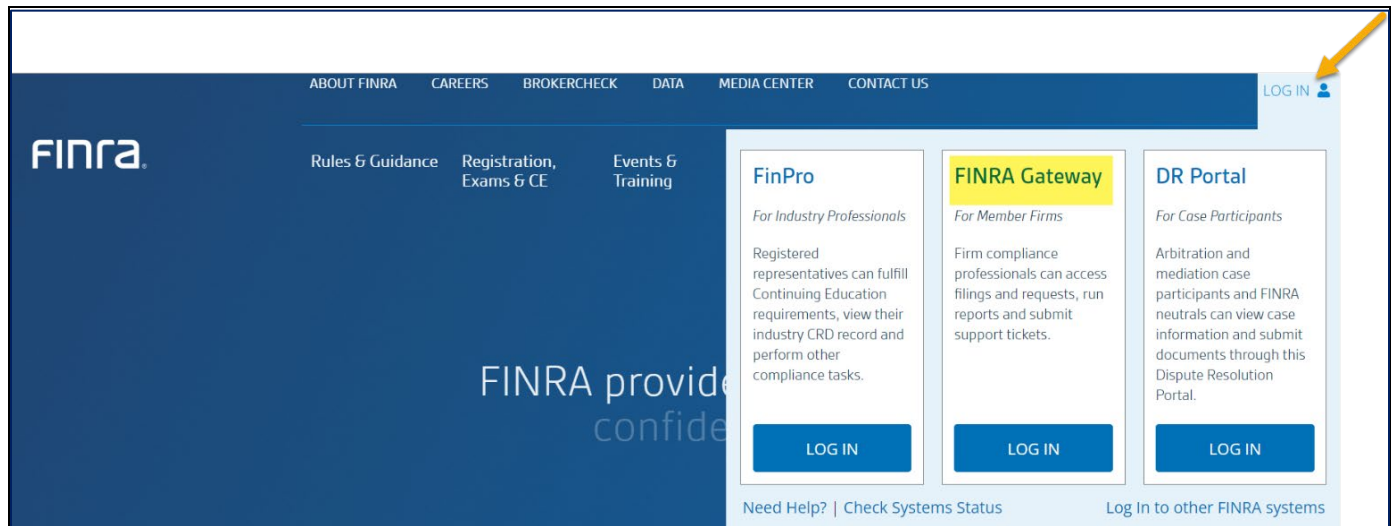

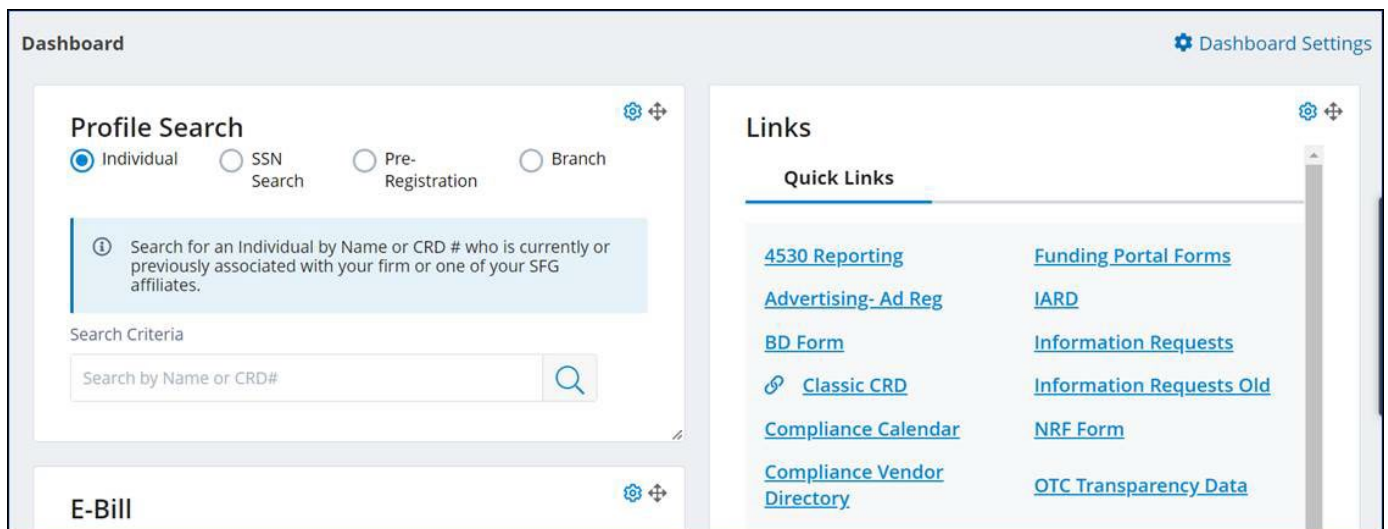

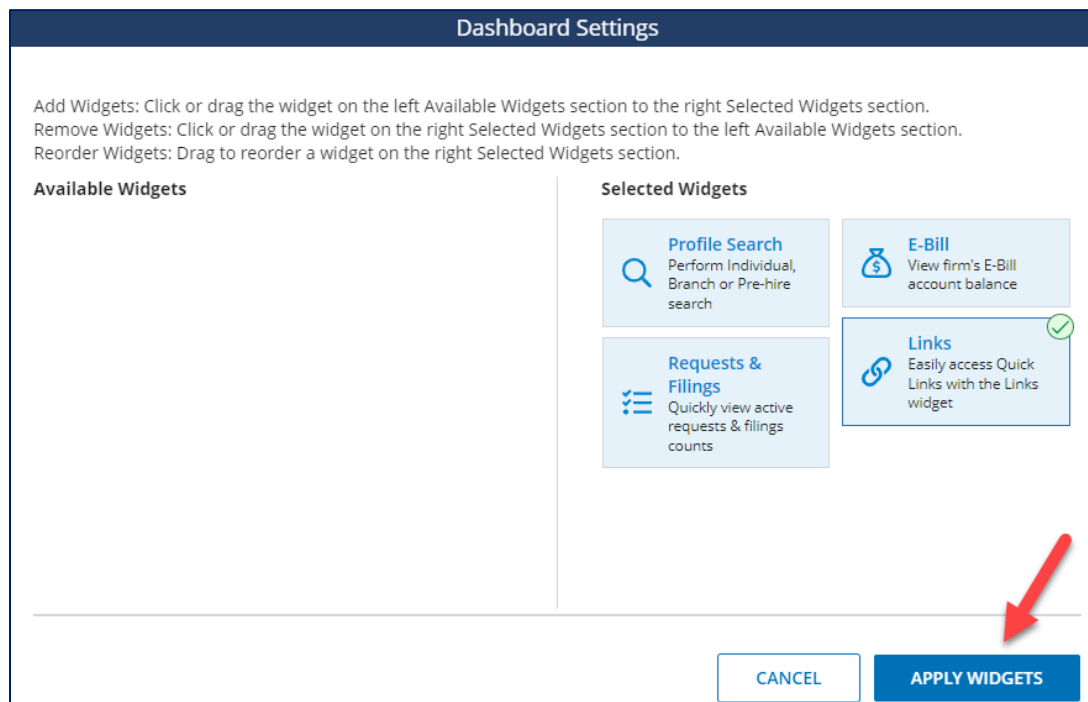

The New Communication Form - Overview

The New Communication Form has five sections, which need to be completed before submitting the form.

After completing the form, you may [Save as Draft](#) or perform a [Print Preview](#) in addition to clicking [Submit](#):



- **Save as Draft** will save the form and allow you to re-open it from the AREF home page and complete at a later date before submitting to FINRA.
- **Print Preview** will open a printer-friendly preview of the form in a separate browser. You can right-click on that view to use your browser settings to print a copy.
- **Submit** will upload your completed form and:
 - assign the communication a reference number; and
 - provide an estimated fee amount for the filing review.
- **Close** will return you to the AREF home page.







Set Read/Unread

- Ability to bulk change Unread to Read or Read to Unread

1. Filing ID/View Details

- Click to view details for the filing

2. Status

- Displays the status of the filing (Draft, Pending, Read or Unread)

3. Reference No.

- For a Draft filing, this will say 'Draft'; for **Unread** or **Read**, clicking the reference number will open the most recent communication from FINRA.

4. External Ref. No.

- Firm's Internal Tracking Number

5. Sent In

- Displays the date the filing was submitted

6. Comment Letter Addressee

- Displays the name of the person to whom the FINRA Letter is addressed

7. Sent Out

- Displays the date that FINRA sent a response

8. Overall Result

- Displays the overall result for the filing

To filter by a value in a column, simply click on the column heading and choose the desired function:



Notes

- The Filing ID is the unique identifier for each filing created and displayed on the AREF home page, which is used to view details of the submitted filing.
- In contrast, the FINRA Reference Number, is generated when the filing is submitted and remains the tracking number for the filing.
- The Status of the Filing indicates what actions are available:
 - Draft** – has not submitted to FINRA; you can click on the Filing ID to complete and submit.
 - Pending** – submitted to FINRA with no response.
 - Unread** – there is a FINRA response that has not been read.
 - Read** – there is a FINRA response that has been read.

Note: Users can toggle on **Unread** and **Read** to update the status. (Ex. change Unread to Read).



Users can use the 'Set Read/Unread' column to change multiple statuses of **Unread to Read** at the same time. (You can also change several Read to Unread at the same time)

- To read the latest FINRA response to a filing, click the Reference Number.
- To review all FINRA communications for a filing, click on Filing ID and navigate to the Additional Information / FINRA Communications section.
- When you filter by a value in a column heading, the filter icon (∇) appears at the top of the column heading.
- To clear a filter or sort order, simply click the column heading and choose 'Clear Filter.'

Description

Through the use of XML meta data files as well as associated documents are transmitted via fileX protocols (SFTP, HTTPS Rest & S3 Direct). Batch Submission enables FINRA member firms to submit a large volume of Advertising filings directly to a secure server and to automate and streamline the submission process.

Firms with a high volume of advertisements (typically around 500 per year or more) may find that batch submission is more efficient than manually submitting pieces to FINRA one at a time using the AREF (Advertising Regulation Electronic Filing) web site.

Implementation steps for firms new to batch submission

Typically, the steps to start using Batch Submission look like the following:

1. Read this document thoroughly;
2. Read the fileX user guide thoroughly; [Click Here for fileX Details](#)
3. Have a preliminary conversation with FINRA;
4. Acquire all necessary accounts and verify connectivity to FINRA;
5. Settle upon an FTP mechanism or FTP client software;
6. Develop XML-constructor software, working through any questions with FINRA;
7. Upload several test filings to FINRA's Customer Test Environment (TEST) and work out any issues with XML formatting and the upload process;
8. Acquire verification from FINRA that the test files were received properly;
9. Begin uploading actual advertisements to FINRA's production servers.

Required contact information

FINRA makes announcements regarding AREF and the Advertising batch submission system. Therefore, please provide contact information for both a technical contact as well as a business contact. It is strongly recommended that this information is kept updated. Please send the contact information to Advertising-Technology@finra.org.

Requirements to submit batch filings

To submit batch filings, the following **five** items are required:

1. Advertisement(s) in a file format acceptable to FINRA
2. Structured metadata in an XML file format,
3. EWS account with entitlements to AREF,
4. SFTP, HTTPS REST, or S3 Direct access to FINRA via fileX,
5. EWS machine to machine(FTP) accounts for Advertising Batch Submissions
 - a) FINRA Test Environment FTP account
 - b) FINRA Production FTP Accounts

Note that the accounts in numbers 3 and 5 are distinct accounts, each with their own username and password.

1. Advertisement(s) in a file format acceptable to FINRA

You must have all files to be submitted, including the advertisements themselves in a file format acceptable to FINRA (PDF, audio-video, and MS Office formats), together with the associated metadata required for submission (e.g., date of first use, name of principal that approved the communication, whether the communication will be preceded or accompanied by a prospectus, etc.).

2. Structured metadata converted to XML file

You will also have to develop a tool to consolidate all structured data (See Appendix A for a full list of data requirements) into a single batch file that conforms to the XML schema definition (See Appendix C). This file must be suffixed by “.mdata” to be processed.

3. EWS account with entitlements to AREF

Access to the vast majority of FINRA systems is controlled by FINRA EWS (Enterprise Web Security) accounts. Typically, users of FINRA systems need only one username and password to access all applications to which they are entitled.

To submit Advertising batch filings, two accounts are needed: one to allow the machine to machine (FTP) communication to transfer the file via fileX, and one web(human) account to access AREF (Advertising Regulation Electronic Filing).

If your firm is currently submitting advertisements electronically to FINRA, then you already have at least one user with entitlements to AREF, and those credentials could be used.

If your firm does not currently submit electronically, you can ask your firm account administrators – the people at your firm who have the rights to create EWS accounts – to create and entitle a new account.

If you cannot determine your account administrators, please call the FINRA Call Center at (800) 321-6273 and select option 1 for entitlements questions. The operator can help you more easily if you know your firm’s CRD number.

4. File Transfer via fileX to FINRA

You will need to determine whether or not your firm has already established access to FINRA’s fileX servers in order to submit other regulatory information. The Regulation Filing Administrator within your firm can provide you with this information. Questions regarding obtaining access to the system can be directed to (800) 321-6273.

Note that while most FTP clients can support the technical requirements of Batch Submission, FINRA does not provide technical support for any client software. Firms need to understand that it is their responsibility to be sufficiently proficient with their applications.

1. HTTPS Rest (port 443), SFTP (port 22), and S3 Direct protocols are supported. Please refer to the fileX user guide for additional information regarding the various supported file transfer protocols;

The SFTP option requires FINRA to open a port on its firewall, tied to a specific source IP address on the customer’s side. This process requires a bit of paperwork and a lead time measured in weeks.

5. EWS FTP accounts for Advertising Batch Submissions

Beyond the ability to connect and transmit via fileX to FINRA (described above), you will also need machine to machine(FTP) credentials. These credentials are just for the fileX server and are completely different from the normal FINRA EWS (Enterprise Web Security) credentials that are used for most web-based applications.

You will need a separate account for both the Test and Production environments.

a. FINRA Test Environment FTP Accounts

If your firm does not have an FTP test account, please send an email to Advertising-Technology@finra.org requesting a test FTP account be set up for submitting Advertising Batch Submissions. An account will be provided.

b. FINRA Production FTP Accounts

If your firm does not already have an FTP account, the "FINRA Entitlement Form FILE TRANSFER Applications FTP User" form can be obtained by calling the FINRA Gateway Call Center at (301) 869-6699.

Within Section 4 – Entitlement Privileges, please select the checkbox labeled, “ADV File Transfer” to add or remove entitlements for Advertising File Transfers.

Please note that this form must be signed by one of the following:

- FINRA Account Administrator
- Executive Representative
- Direct Owner
- Indirect Owner
- Executive Officer

Accounts on the production and test FTP servers are not synchronized, so even if you create an account with the same username on both servers, the passwords can be different, and changes to one will not cascade to the other.

Submission and review process: Test environment

The below instructions refer explicitly to FINRA’s **Test Environment**, which is a sandbox offered to firms who are developing automated interfaces to FINRA’s systems, and populates only QC databases on FINRA’s side (not actual production systems).

This test environment should be used by firms to **test** the batch submission process (with help from FINRA), **before using the production system.**

Submissions or other actions in the test environment will have no effect on actual filings by your firm within the production system.

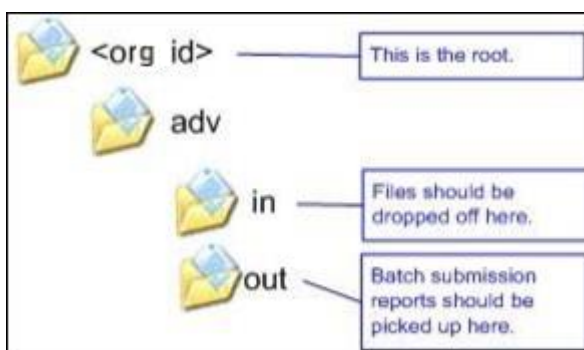
The test environment is not covered by an SLA, and is therefore not guaranteed to be up at all times, particularly evenings and weekends.

The following environment- specific variables are to be used for the test environment:

- AREF Online Test environment is: **<http://firms1.qa.finra.org/firm-gateway>**
- fileX (Lower QA) Test Batch FTP Server: Please view the 'Environment and Connectivity' section of the fileX user guide; [Click Here for fileX Details](#).

To submit the file

- Connect to the FINRA fileX Servers via selected protocol (SFTP,HTTPS REST, or S3 Direct) – refer to appendix F for server.
- Authenticate in with a valid FTP account and password
- Note that the FTP servers will lock out an account after 3 consecutive failed attempts to connect, so verify your username and password carefully if you experience an error.
- The diagram below illustrates FINRA's batch submission folder structure. Note the two child folders: one is used to deposit files ("in") and a different folder is used to retrieve FINRA submission reports ("out"). Change your directory to the adv/in folder.



- For file submissions: **cd adv/in**
- For report & communication retrievals: **cd adv/out**
- For archived file submission: **cd adv/in_arcv**
- Each submission must be accompanied by its own meta-data file. This is being done due to the complexity of tracking more and larger files for multiple communications back to a single meta-data file and still being able to provide accurate timely responses to firms for submissions.
- When uploading files as part of an ADV submission, the meta-data file **MUST** be the LAST file uploaded. This file will act as an end of submission marker for FINRA letting us know that all files necessary for the submission have been successfully loaded to FINRA. As the meta-data file validation starts the process, we can be assured that all files identified within the meta-data reside within processing, thus eliminating the need to set aside submissions and wait for files that have not yet arrived at FINRA.
- As a matter of process, we ask that no communication be resubmitted once the meta-data file has been transmitted until the Filing Report has been received by the firm. This ensures that the second submission does

not get rejected as a duplicate submission. This is required to ensure we have proper time to reset the environment with regard to files previously submitted.

- Allow the transfer of the file to complete, then view your transmitted file in the adv/in_arcv directory.

To retrieve the output report files

Batch files will be processed Monday through Friday 0000 – 2300 Eastern Time every 10 minutes. However, due to the acceptance of larger file sizes, there could be some delays during peak transmission times. Once the file processing cycle has started, another cycle will not start until the current cycle finishes. With larger files come higher transfer rates between servers which may cause a few cycle times to exceed 10 minutes.

Files may be sent over to FINRA on non-business days, but will not be processed until the next business day.

After the processing of your filing is complete, the requested filing report formats are placed back into your fileX directory. The first file is a text formatted output report (See Appendix D) called RPT_XXXX.txt (where XXXX is the complete filename you uploaded to FINRA). The second file is an XML formatted output report (See Appendix B) called RPT_XXXX.xml.

We changed the format of the file name of the Filing Report to provide you more information without having to open and parse the report itself. The new Filing Report will have a file name in the format: <mdatafilename>_<UID1>_[FINRA Reference Number | REJETESTD].[TXT | XML]

(examples: <mdatafilename>_<UID1>_FX2014-0404-0148.TXT or <mdatafilename>_<UID3>_REJETESTD.XML)

We changed the XML schema for the Filing Report to simplify it and allow for better detail reporting of rejected submissions. Where possible we give as an extensive validation as the data submitted allows. The goal is to make completing the submission process as easy as possible. Samples of both the XML and TXT Filing Report formats are provide at the end of this document.

As a matter of general practice, the output file should be available in the “out” folder within one hour from the time the file is uploaded to fileX.

Reminder: the output files are retrieved from the “out” folder, not the “in” folder where the files are dropped off.

- Get your output reports (Example: Get RPT_XXXX.xml or Get RPT_XXXX.1)

To review submitted filings

Following the submission, you can review the packets using the AREF online system (refer to the [New System Navigation guide](#)).

Batch Send option for receiving FINRA communications

This option is only available for filings submitted to FINRA via the Batch submission process. Please note that whether a firm uses this option or not, all communications will remain available through AREF.

The Batch Send of FINRA Communication letters is activated on a filing by filing basis via use of the optional 'BatchSendFI' tag. Firm participation of the Batch Send Process must be explicitly declared submitting a filing. If a firm does not supply the XML tag 'BatchSendFI' or supplies a value not = 'Y', then the FINRA communication letters associated with that filing will not be available to the firm via fileX.

The communications will be delivered as PDF files. The Member firm can retrieve the PDF files and process them as is. As multiple communications can be sent referencing the same submission, FINRA recommends that firms' scripts include an explicit removal of the file from the FTP "out" directory on the FINRA FTP server once the document has been retrieved.

The File Name will be the FINRA Reference number (RPT_F[R|X]YYYY-MMDD-NNNN) assigned to the filing at the time it is submitted, followed by a B and a 3-digit number representing the communication sequence number. For released filings, the seq. number will be followed by the 8-character Final Result code. The full file name will look like "RPT_FX2014-0404-0148_B002.PDF" or "RPT_FR2014-04040135_B003_OK.PDF". Values that can appear here are the same values that currently appear in the AREF Cabinet (OK, REVISE, DONOTUSE, etc.).

Submission and review process: Production

The below instructions refer explicitly to FINRA's **production environment**.

Submissions in the Production environment will be treated as actual filings by your firm.

FINRA's test environment mirrors the production environment. So, once you have completed all test processes and are ready to use the production system, the instructions that precede this section remain the same, except for the following environment-specific variables:

- Production AREF Application environment is: **<https://firms.finra.org>**
- FINRA fileX Batch Server is: Please view the 'Environment and Connectivity' section of the fileX user guide; [Click Here for fileX Details](#).

Troubleshooting and Frequently Asked Questions

I can log into TEST but not production fileX server (or vice versa)

Accounts on the production and TEST(Lower QA) fileX servers are not synchronized, so even if you create an account with the same username on both servers, the passwords can be different, and changes to one will not cascade to the other.

To change the TEST password the administrator (using his or her production account and password must log on to the TEST web site.

“Invalid Submitter user id” (expired user accounts in TEST)

Two sets of credentials are needed to execute a batch submission:

- the FTP account, which allows the file to be transferred, and
- the AREF Website user (FINRA EWS) account, the username of which is embedded in the XML and allows access to the Advertising systems. Prior to using an AREF Website user account within a batch submission, the user must first log in to AREF in Firm Gateway (<https://firms.finra.org/>) and fill out the Registration Information. The batch submission will fail if the account does not have the Registration Information and will display this error.

The second of those accounts (the EWS account) is subject to periodic deletion as part of an occasional refresh of the TEST databases.

If you should be testing in TEST and receive a Batch Submission report with an error message similar to the below message, it is likely that the EWS account, while still valid, has been deleted from the TEST environment:

To correct this, please ensure that you are using the correct account – the EWS account, and not the FTP account.

Invalid XML errors

XML is a standard protocol for representing structured data. This standard allows and disallows various characters. Disallowed characters often have a substitute string that will be translated to that character. For just one example, the special character "&" (ampersand) causes a failure in XML. If you wish to use it literally, you must use "&" for the ampersand character. Please consult the XML standard for more details.

Can a firm use both Batch and online AREF at the same time?

Yes, both batch and online AREF work together. A firm can submit some filings by batch and others online. Filings submitted by batch can be viewed online and online is used to submit subsequent communications if they are not included in the original submission.

Is there an additional cost to submitting filings by batch?

There is no additional cost for filing by batch. Filing charges are the same whether the filing is submitted by batch, by online AREF or by hard-copy.

Can Service Providers batch file on behalf of Member Firms?

Service providers are defined as organizations who are not FINRA Member Firms, but whom have been engaged by FINRA Members Firms to process work on behalf of those firms. The AREF System does not directly support Service Providers and FINRA does not maintain a relationship with Service Providers for purposes of AREF. However, individual Member Firms are free to engage Service Providers to perform work on their behalf.

If a FINRA Member Firm does engage a Service Provider, the Member Firm is responsible for providing all access, including user IDs and passwords, to that Service Provider as indicated in the several sections above. Additionally, the Member Firm remains responsible for all connections and filings the Service Provider makes on behalf of that Member.

If a Service Provider is engaged by more than one Member Firm, each Member Firm must provide the Service Provider with a separate account for each firm.

A white rectangle will appear around column headings that are sorted using filter options. Use the CLEAR ALL button to clear the fields. Click CLOSE to close the filter options. Note: Filters are working with the data displayed based on the date range selected.

6. **Sorting** - All columns can be sorted ascending or descending by clicking on the column name. A triangle will appear next to a column that has been sorted, either pointed upward or downward to indicate an ascending or descending filter, respectively. The default sort is descending.

7. **Export** - Account Detail information within the Activity, Fees and Specific Date Fees tabs can be exported to a .csv file. Navigate to either the Activity, Fee or select a specific Fee date tab. Click the Export button adjacent to the Show Filters icon. Please note that export is limited to 35,000 records.

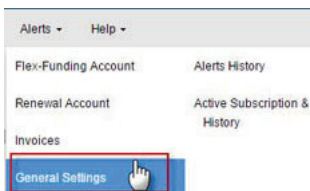

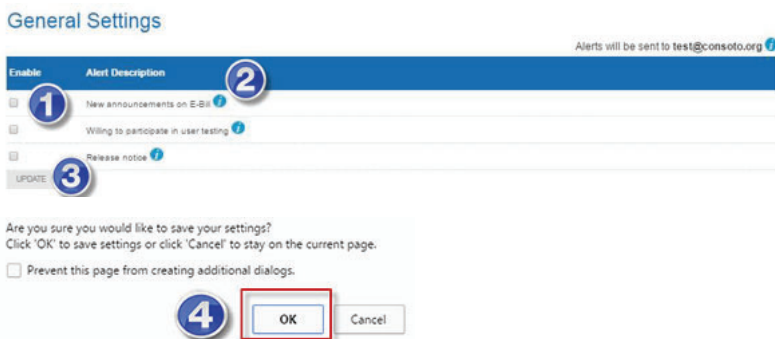

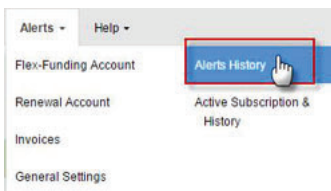

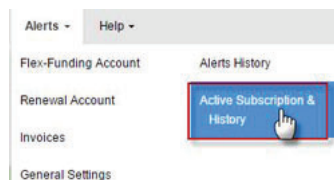

The SAA view differs from the standard signed-in user. The SAA has read-only ability to review alerts that have been subscribed to by other user(s). However, the SAA cannot subscribe users to Alert subscriptions. **Each user must subscribe to alerts individually.**

1. Financial transactions are available as downloads via the reports tab.
2. Relevant parameters can be selected before generating the reports.
3. Reports can be generated as PDF and CSV.

Procedures:

E-Bill Terminology

Flex-Funding Account – The Flex-Funding account is the primary account in which firms deposit funds for day-to-day registration transactions to occur or invoices be paid.

Renewal – Financial activity related to the annual renewal program, including the Renewal Statement and historical renewal payments.

Sufficient Account Status – Projected Balance of firm's Flex-Funding Account is \$0.01 or more. Sufficient status is indicated by a positive number.

Deficient Account Status – Projected Balance of firm's Flex-Funding Account is \$0.00 or less. Deficient status is indicated by a negative number. If the firm's account balance goes below \$0.00 at any point throughout the day, the firm's account status will become Deficient and fees will not be processed until the account becomes Sufficient again.

Estimated Balance – This is an ESTIMATE ONLY and may be subject to additional transactions that are not reflected due to overnight processing. Estimated Balance is the net of Last Posted Balance and any Funds Deficient Transactions and Pending Transactions.

Estimated Balance Status – The Estimated balance status is defined as Sufficient or Deficient and is dependent on the running balance.

Last Posted Balance - This balance includes transactions posted to the account. Transactions are posted during overnight processing – please refer to www.finra.org/ebill/ for the processing schedule.

Funds Deficient Transactions - Registration/exam requests that are held until there are sufficient funds in the Last Posted Balance to pay for all Funds Deficient Transactions.

Pending Transactions - Transactions submitted via E-Bill and CRD/IARD but not yet been posted to the account. Pending checks and wires are not included. Pending transactions are generally posted during the next overnight processing cycle and then reflected in the Posted Balance.

Beginning Balance – Posted balance at the beginning of selected date range.

Ending Balance – Posted balance at the end of the selected date range.

Deposits – Deposits made into the Flex-Funding Account.

Fees – Day-to-day registration transactions

Withdrawals – Any funds withdrawn from the firm's Flex-Funding Account that are not related to the CRD/IARD.
